Dear Madam,

The Board of Directors of Birlasoft Limited ('the Company') issued the postal ballot notice dated February 14, 2023 (hereinafter referred as "Notice") and decided to provide to the members of the Company, facility to exercise their voting rights on the resolution as set out in the notice through Postal Ballot ("remote e-voting"); as required under the provisions of Section 108 and 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014.

I, Jayavant B. Bhave, Proprietor, M/s J. B. - 5. After the closure of Voting period on Thursday, March 23, 2023, I have unblocked the electronic votes in the presence of two witnesses not in the employment of the Company.
